

## PHA Club Membership Application for FY 2021

To join Piedmont Handgunners Association, you must attend at least one monthly meeting of the club. The meetings are held at Ocean View Seafood, 1803 Cotton Grove Rd, Lexington NC 27292, on the 2nd Thursday of each month, except December. When you arrive, let the Membership Secretary know you are there as a new member.

As you enjoy your dinner, talk with the members around you. PHA is an organization of shooters with widely varied interests and you may find folks with similar interests to yours. By getting involved you will make new friends and get more out of your membership. Please observe the meeting and how PHA business is conducted.

These are things you need to know and understand to become a member of PHA.

- You must be eligible under the requirements of the organization.
- You must complete and sign this application and the Range Rules attachment. By doing so, you are agreeing to abide by our rules for membership.
- After the meeting is a good time for questions, but feel free to ask during the meeting.
- You must complete a walk-through (range safety orientation and safety shoot at PHA Range facilities) with a PHA Board Member. Please arrange for your walk-through appointment at the end of the business meeting. You must bring your completed application, signed Range Rules, and a handgun with a handful of ammunition with you to the walk-through. After completing the walk-through, you can then write your check and you will receive a temporary membership card and gate access code.
- The one-time initiation fee is \$300 plus annual dues for the first year which is \$125. You must submit an application along with fees--\$425.00 for the first year. The renewal fee is \$125.00 per year thereafter.
- Make all checks payable to Piedmont Handgunners Association. Our mailing address is: PHA, PO Box 913, Thomasville NC 27360.
- Remember that with 1300+ members, there are wide and varied shooting interests, so please be considerate of others under all circumstances.
- Spouses and immediate family have full range privileges when accompanied by a member, but they must always remain in the presence of the member.
- PHA Range facilities are for PHA members and their guests (2 per member).
- Memberships are allowed only one vote.
- All applicants will be on a one-year probationary period.
- If applicant cannot attend a PHA meeting due to work schedules, arrangements can be made to meet with an officer of the club for an interview.
- Your spouse may be credentialled after reading and signing the Range Rules and completing a walkthrough with a board member. Children of members may come to the range with the member at any time (and are not counted as guests) but they **must always remain in the presence of the member**. Children of members are eligible to join and have full range privileges at age 18 upon completion of all requirements for membership in PHA as set forth in this application.

Range Rules Received

**PIEDMONT HANDGUNNERS ASSOCIATION RANGE RULES FY 2021**

1. Safe firearms handling is a prerequisite for use of our range.
2. All firearms will be kept unloaded (except when on the firing line) and muzzles pointed in a safe direction.
3. No firearms may be handled for any reason when anyone is forward of the firing line (COLD RANGE condition).
4. Any time the range is called cold, all firearms will be unloaded and benched, with magazines removed or bolts, slides, and cylinders open. Use of **Empty Chamber Indicators** (ECI) is highly recommended.
5. Every member is a Safety Officer and has the responsibility to politely remind someone about our rules should they observe an unsafe act or a safety violation. Do not act confrontational but make a Board Member aware of the situation if the situation cannot be corrected in a professional manner.
6. PHA Range facilities are for PHA members and their guests (2 per member).
7. Range shooting hours are from 8:00 am until legal sundown, although a member may come and go outside these hours.
8. All targets must be placed directly in front of the berms. **Do not place targets between firing point and the leading edge of berms since this can cause dangerous ricochets.**
9. No shooting at rocks, bottles, cans, or other trash type objects.
10. Shooters under 16 years of age must be under direct adult supervision. Guests must stay in the company of the member they are accompanying but may be firing at the same time as the member.
11. Members and guests are required to observe common courtesy and allow others to post and check targets within reasonable limits. Likewise, shooters should not be unreasonable in their requests for posting or checking their targets.
12. Fire only at targets directly in front of your firing point. Angled shots may not hit or be stopped by the berms.
13. **HUNTING ON PHA PROPERTY IS STRICTLY PROHIBITED.**
14. Members must display their membership badges on their person or their range equipment if it is on the line.
15. **NO ALCOHOLIC BEVERAGES ARE ALLOWED ON PHA PROPERTY AT ANY TIME.**
16. Use of exploding targets of any description or manufacture is not allowed at any time.
17. Full auto, slide-fire weapons, or any weapon with a binary trigger or any burst trigger system is **NOT** allowed on PHA ranges.
18. Eye and ear protection are required on or directly behind the firing line by all shooters and observers during any firing phase.
19. Members and guests are required to clean up their area of any trash or debris. Please leave the range better than you found it.
20. Entrance gate should be opened and relocked **by members only** upon entering or leaving PHA range. (Sharing the combination with a non-member is cause for loss of membership!)
21. Any acts of vandalism observed should be reported to a board member immediately or as soon as possible to allow for a review of the cameras to identify the responsible party. If possible, (without confrontation) an attempt should be made to identify the person committing the vandalism by name, description, or license plate number and description of vehicle.
22. Commands from Range Officers, Match Directors, and Board Members must always be obeyed as it relates to safety and operation of PHA Range Facilities.
23. All pets must remain inside your vehicle while you are on PHA Range property.

**Violation of the above rules is or may be cause for expulsion from PHA without a refund of dues.**
